

The **Bobtail Delivery Operations** course provides information for drivers who operate commercial motor vehicles to deliver propane. It provides practices and procedures that support many general delivery tasks. This class is primarily designed to train employees who operate a bobtail, the most common vehicle used for transporting and delivering propane to individual customers.

The topics covered are:

- DOT licensing and driving requirements.
- Vehicle inspections, identification, and documentation.
- Safely handling hazardous materials.
- Handling Out-Of-Gas calls.
- Driving defensively.
- Vehicle parking, servicing and security.
- Bobtail equipment and systems, including cargo tank, gauges, valves, pumps, meters, delivery hoses and emergency discharge control equipment.
- Procedures for safely loading a bobtail using the plant pump.
- DOT requirements for bobtail inspections.
- Features and installation requirements of ASME tanks at customer locations.

What to expect: Students will take quizzes and tests to assess their pace of learning. A multiple-choice test will be administered at the end of the class.

Tests are graded by a third party and the results are mailed to each company. A score of 70% or higher is required to pass the test.

Registration includes: the cost of student and test materials, pencils, markers and other materials. Lunch and refreshments are also provided. Other meals, lodging and travel are not included in the class fee.

Copies of NFPA 58, the LP-Gas Code, are available for purchase separately. See accompanying brochure for order information.
