Dispensing Propane Safely

The Missouri Propane Gas Association is proud to offer the 2023-2024 Fall/Winter schedule for Dispensing Propane Safely Training. Training sites are located conveniently throughout the state.

Missouri state regulations governing propane safety require that all persons who dispense propane must receive statecertified propane safety training as soon as the training is available in their area. It is also required that anyone dispensing propane have training every three years and the recurring training must also be a statecertified program.

It is a violation of state law for any untrained person to operate a dispensing device. The owner or manager where the dispenser is located is responsible for ensuring that all employees who operate the dispenser at that location receive statecertified training every three years.
