Board Member Expectations and Requirements

A strong board directly correlates to the success of an association. Therefore, there are some general expectations and requirements for board members.


- Attend and actively participate in all board meetings, usually four per year.
- Serve on at least one of the MPGA Committees – Government Affairs, Convention, Membership Committee or others.
- Attend each of the MPGA's annual events including the Family Outing, District Meetings, Mid-States Expo, events at the Missouri Capitol and any other special events.
- Contribute to the MPGA and NPGA Propane PACs and financially support other programs such as the scholarship fund.

Nomination and Election Process

Elections for MPGA Marketer and Associate board members will be held this spring. Any Marketer or Associate member in good standing may nominate themselves or another member for a seat on the MPGA Board of Directors by contacting the Association office or completing the form below. **Nominations must be submitted by March 8, 2024.**

- If more than one candidate seeks election, ballots will be mailed on March 15, 2024, and are due back at the MPGA office by April 12, 2024.
- Election results will be announced during the MPGA Board Meeting on April 16, 2024.
- Elected Regional and Associate Directors will serve two-year terms beginning at the 2024 Annual Meeting and expiring at the 2026 Annual Meeting.
- Companies are limited to no more than 3 representatives total on the board and no more than one per Region.

Region 4: Counties of Barry, Barton, Cedar, Christian, Dade, Dallas, Douglas, Greene, Jasper, Laclede, Lawrence, McDonald, Newton, Ozark, Polk, Stone, Taney, Webster and Wright.

Region 5: Bollinger, Butler, Cape Girardeau, Carter, Dent, Dunklin, Howell, Iron, Madison, Mississippi, New Madrid, Oregon, Pemiscot, Perry, Reynolds, Ripley, Scott, Shannon, Stoddard, Texas and Wayne.

Associate Director: Representative of a company engaged in the manufacture or distribution of fuel, equipment or services for the benefit of Missouri-based marketers. Two Associate Directors are elected annually to serve 2-year terms.
